The Question of Palestine Newsletter 6th Edition, July 2020









In October 2018, the Arab Renaissance for Democracy and Development (ARDD) inaugurated a major three-year initiative on "The Question of Palestine 70 Years On: Priorities for Action" which aims to foster new, innovative thinking into discourse around the unresolved Israeli-

Palestinian conflict. The Global Network of Experts on the Question of Palestine (GNQP) – established by ARDD as part of this initiative – employs various avenues of coordination in order to serve as a platform for enhancing and expanding substantial discourse on the question of Palestine from a human rights based approach.

In this edition

Since the last newsletter, the world was shaken by the novel COVID-19 virus. As of 12 July, there are more than 6158 confirmed cases in the West Bank and 72 confirmed cases in Gaza. Among Palestinian refugees in the UNRWA areas of operation, 724 cases were registered until 11 July. In the past weeks, the West Bank (as well as Israel) has seen a significant rise in cases and as a consequence, the state of emergency was extended for another 30 days. Concerns were in particular high for the situation in the overcrowded Palestinian refugee camps in the region and especially in Gaza, as the densely inhabited strip faced major humanitarian challenges due to the siege are currently exacerbated by the health crisis. In the West Bank, a rise in Israeli settler attacks against Palestinians and their properties was reported amidst the pandemic. Simultaneously, Israel did not hesitate to advance planning of the implementation of the US Administration's Peace to Prosperity Plan or "Deal of the Century". As such, Israel announced the implementation of the annexation of considerable parts of the West Bank starting from 1 Meanwhile, despite the rapidly spreading virus, house July 2020. evictions and demolitions took frequently place displacing entire Palestinian families. In response to the evolving events, the GNQP actively published and shared their knowledge and analysis through different channels.

The 6th edition of ARDD's quarterly newsletter on the Question of Palestine – through a selection of articles, reports and testimonials – showcases information and news from our experts, relevant institutions, and reporters tackling Palestinian issues and aims to raise awareness about the conflict's background in order to conduct meaningful dialogue about Palestinian identity and future policy.

GNQP Efforts

The COVID-19 pandemic serves to reflect on the cost of systematic oppression: although the virus is said to not discriminate, the sociopolitical conditions of an individual define the degree of vulnerability in face of a health crisis and the consequential economic implications. Members of the GNQP actively monitored - and continue to do so - how COVID-19 affected the Question of Palestinian and issued three position papers:

The <u>first position paper</u> sheds light on the situation for Palestinians under occupation in times of COVID-19. This paper was launched on the 72nd Anniversary of Al Nakba Day and denounces the continuous Israeli violations against and negligence of obligations toward Palestinians under international law. The <u>second position paper</u> focused on the impact of COVID-19 on Palestinian refugees in Jordan, Lebanon, the occupied Palestine territory and Syria, analysing how the virus combined with their distinct refugee status puts them at significant risk of infection in the overcrowded camps. Moreover, Palestinian refugees are often limited in accessing health care due to marginalizing laws and policies. The third position paper addresses the various developments including those with regard to Jordan - related to the impending annexation plan of 30% of the West Bank, encompassing the Jewish settlements and the Jordan Valley. German newspaper Der Freitag, and later Mondoweiss, published an article based on the position paper with regard to the consequences of the annexation for Jordan. The implementation of this activity is a result of the "Deal of the Century" that the GNQP condemned in its latest statement.

ARDD's Efforts

As part of "Voices and Future of Refugee Youth from and in the Arab World" week, on the occasion of World Refugee Day, ARDD published its newest study on Palestinian refugee youth: "Voices of Palestinian Refugee Youth across the Near East: Socio-Political Participation and Aspirations." The study sheds new light on Palestinians by focusing on a usually politically marginalized segment of the communities: refugee

youth from Jordan, Lebanon, occupied Palestinian territory and Syria. Their perceptions and aspirations about their status within communities and within host societies, as well as about their future, are important albeit often muted. Based on the findings, ARDD compiled a policy brief (to be published soon) titled "Enabling Social and Political Participation of Palestinian Refugee Youth," written under the assumption that efforts to improve the economic marginalization of Palestinian refugee youth must underpin programmatic initiatives regarding political participation efforts, as decent livelihoods lay at the basis of youth's future in their communities and the region.

Consistent violence by Israeli forces against Palestinians has caused the death of Eyad Hallaq, a 32-year-old unarmed Palestinian with autism. His death, in light of current debate around Black Lives Matter, exposed and sparked debate on the apartheid regime institutionalized by Israel and the injustices toward Palestinians that this system enables. In response, ARDD started a petition on behalf of civil society calling for solidarity with the victims of racism.

On Sunday 21 June, ARDD held an interactive dialogue in a special World Refugee Day edition of #AlNahdaYouth sessions, titled "Refugee Youth Voices: Challenges and Aspirations," whose speakers represented Syrian, Somali and Palestinian refugee communities in different regions in Jordan. The session offered an insight into the intricacies of refugee experiences and revealed common aspirations and priorities youth have for the future. Also, ARDD, founding member and coordinator of the Jordanian National NGOs Forum (JONAF), signed a memorandum of cooperation between ARDD and the Palestinian NGO Network (PNGO). This agreement aims to enhance the exchange of experiences between JONAF and PNGO, in particular in coordinating COVID-19 response initiatives.


